- 1. Shri.G.Arunagiri was relieved from RRTC on 09.02.2004 vide ltr no: RRTC/Mds/04-140,141,142 dated 09.02.2004 and was attached with NIOH. He joined NIOH on 16.02.2004 where he had continued with CPF scheme as NIOH had the provision.
- 2. He was redeployed to NIEPMD Chennai vide Lr.No. NIOH/Recruit/03/424(11) dated 20.04.2006. He joined NIEPMD on 22.04.2006 and superannuated on 31.05.2007.
- 3. NIEPMD was established in the year 2006 and did not have CPF A/c. The accumulated amount of CPF in the account of Shri G.Arunagiri received from NIOH was returned to Shri G.Arunagiri.
- 4. A Government Employee at any point of time in service should be covered under any pension scheme, Shri G Arunagiri was put under NPS at NIEPMD as NIEPMD had only NPS then.
- 5. After superannuation, Shri G.Arunagiri filed a Writ Petition in the Hon'ble Madras High Court claiming for gratuity, pension and other terminal benefits.
- 6. As per OM dated 01.05.1987 issued by The Ministry of Personnel, Public Grievance & Pension, New Delhi wherein it was clearly stipulated that all CPF beneficiaries in service on January 1, 1986 and who were in service at that time, should be deemed to have come over to the pension scheme on that date unless they specifically opt out to continue under the CPF.
- 7. Shri G.Arunagiri submits in his affidavit that he has not given the option to continue with CPF Scheme.
- 8. Based upon the plea and the case of Smt Nirmala Venkateswaran who was also a RRTC employee, the Hon'ble Madras High Court has ordered to pay pension and gratuity to Shri G.Arunagiri.
