(b) ATR on 26.08.02 : Toll Free number : The Council noted that anapproximate 300+calls are received in the Toll Free number. Other matters discussed :-

(a) Filling up of vacant posts :-

The EC noted that 03 posts of Associate Professor are vacant and out of which recruitment action to fill up one post (Associate Prof (Spl.Edn) has been taken up. As regard to the remaining two vacant posts of Associate Professor; the Council instructed to follow the approved EFC notes and to immediately submit the proposal to revive the posts; and to fill up them in their concerned departments; as per the EFC.
