Draft minutes of 30th Executive Council Meeting of NIEPMD, Chennai held on 03rd November 2017.

Agenda 30.01

Confirmation of minutes of previous meeting (28th EC) and (29th EC):

Decision:

The EC confirmed the minutes of 28th AND 29th EC meeting.

Agenda 30.02

Action Taken Report on Previous meetings of the EC:

Decision:

The EC has approved the ATR on previous meetings of the EC.

Agenda 30.03

The draft annual report of the Institute for the year 2016-17 is submitted for perusal and approval of the Executive Council:

Decision:

The EC has directed to re-submit the annual report in the revised format as prescribed by DEPwD. The Council directed that the annual report of NIEPMD along with audited accounts statement shall be placed before both the houses of Parliament before 31st December 2017.

Agenda 30.04

As per the instructions of DEPwD NIEPMD has submitted the proposal to renaming of the Institute before the EC:

Decision:

The EC has approved the proposal submitted by NIEPMD regarding renaming of NIEPMD as approved by PMO. The EC has directed to submit a compliance report in this regard.

As per the mandate of NIEPMD in relation to the MoU with regard to monitoring the activities of Andaman & Nicobar Extension Center, it is proposed to nominate Dr. Dharmendra Kumar, Associate Professor of PMR, GB Pant Hospital, A&N Islands as Officer on Special Duty for the said Extension Centre:

Decision:

EC has approved the proposal.

Agenda 30.06:

It is submitted to the EC that Dr. MGR Medical University, University of Madras and the Tamil Nadu Teacher Education University, Chennai which provide affiliation to different courses, requires that affiliation be provided for as separate colleges based on the course of study, instead of one single college namely, NIEPMD.

Decision:

While approving the proposal for naming the different colleges run by NIEPMD as mandated by the rules of the affiliating universities, EC has directed that the Award of Certificate in various disciplines issued by the affiliating Universities shall invariably contain the College name, along with the name of the Institute.

Further, the EC noted that NIEPMD being a National Institute under Government of India, cannot be equated like any other institutions affiliated under various Universities.

The EC has directed NIEPMD to take up the matter on TOP PRIORITY.

Agenda 30.07

To save the duration of courses in the field of disability which in turn will attract more persons to take up the course, it is proposed to Start Three years Integrated B.Ed with M.Ed Courses in ASD, MD and LD

Decision:

The council has approved the proposal.

Agenda 30.08

To create more number of Skill Trainers and to identify and develop assistive technologies, it is proposed to Start a new course in D.Ed - Special Education (Skill Training):

Decision:

The Council has approved the proposal.



At present there is no staff such as PA or PS attached to Director Secretariat. Staff drawn from other departments are deployed in Director's office. Hence, in order to meet the minimum Requirement of Staff on in Director's office it is proposed to hire one PA and one Steno on Contract basis for Director's Office:

Decision:

As against the proposed two posts, the EC has approved One post.

Agenda 30.10

In order to address the issue of prevention of Childhood Disabilities, it is prposed to conduct a conference on Childhood disability methods and autism at Jabalpur:

Decision:

The Council directed NIEPMD to re-submit the proposal with cost implication.

Agenda 30.11

As per the directions of EC to explore for CSR sponsorship for assets creation, NIEPMD has proposed to acquire a School Bus through CSR mode. This move will, in addition to catering to the steady increase in the cliental flow, will also result in reduction of expenditure on vehicle hire.

Decision:

The Council has approved the proposal. The EC has directed that NIEPMD shall ensure that the bus is occupied to an optimum extent. A compliance report on the occupancy status of the bus shall be submitted to the next EC.

Agenda 30.12

RCI has identified NIEPMD as one of the Institute to conduct advanced Certificate Course in Inclusive Education (Cross Disability) on Pilot basis for two years. Hence, proposal is submitted to EC for approval:

The EC has approved the proposal. There shall be no financial implication since the course is to be on self sustainable basis.

Approval of EC is sought for to execute a MOU / agreement with CCRH, Ministry of AYUSH, Government of India, to receive the contribution from CCRH (60% of the total estimated cost of construction) for creating infrastructure facility at NIEPMD.

Decision:

Decision:

The EC concurred the proposal with a financial cap of Rs.1.00 (One) Lakh.

Agenda 30.27

In order to start a specialised unit under the Department of Clinical Psychology, it is proposed to engage clinical co-ordinator in Learning disability. In this regard, Modification of essential Qualification is proposed to best suit to the requirements:

Decision:

The EC has concurred the proposal.

The proposal for Engaging consultant on need basis for various activities and services is submitted to meet the target fixed by DEPwD in terms of clinical services, outreach programs, STTP etc.

Proposal for Procurement of Psychology Test Material for specialised unit for LD, procurement of psychology test materials for the centre and Engagement of Clinical Therapist at CRC – Nagpur in order to meet the needs of the clients:

Decision:
