The 31st Executive Council of NIEPMD, Chennai was held at the conference hall of DEPwD, New Delhi on December 21, 2017. The minutes of the meeting are furnished below:

Agenda No.31.01

Submission of annual report of NIEPMD for the year 2016-17 for perusal and approval of the Council:

Decision:

While approving the annual report of NIEPMD, the Executive Council has deliberated on the following issues:

i. SKILL DEVELOPMENT:

- The Executive Council appreciated the role of NIEPMD in placing more number of skilled employees across industry through the skill development program initiative. However, the Executive Council has raised concern about the low level of remuneration for skilled PwDs paid by the industry.
- In order to place the employees trained under skill development at a reasonable remuneration, the EC has directed to place one dedicated officer to explore better options of employability under skill development program.
- The EC has stressed the need to expand the areas of skill development program.
- The EC has directed to organize employer meet at frequent intervals so as to involve the industry in identifying and expanding the areas in which the employees can be placed.
 - EC has directed to add capition, wherever visual presentation is made in ii. the annual report

Decision:

The Council has approved the proposal with the following remarks:

- The budget approval is accorded subject to availability of funds and the expenditure is to be made strictly following GFR;
- The a copy of title of the land in which the building is constructed needs to be submitted to DEPwD immediately.
- On going capital Projects to get priority funding;
- As regards on going projects, a detailed letter to be submitted to DEPwD immediately mentioning the Sanctioned amount for the project, amount released so far to CPWD and the GAP in funding, duly supported with demand from CPWD. This needs to be accorded top priority since all the ongoing building projects need to be completed by 31.12.2018;
- The new proposals under NI Funding amounting to Rs.249.47 lakhs is approved; However, efforts to tap CSR funding for the projects those are appealing to corporate houses / PSUs to be explored;
- As regards establishing centers of excellence for new disabilities included in the RPwD Act, 2016, the council has directed to submit concept notes with Long Term Goals as a driving force. The Council directed that the budget needs to be re-submitted and proposals to be framed in phased manner for implementation, spreading over the entire period of gestation.
- As regards internal Revenue generation the EC has noted that the amount of Rs.220 Lakh should be invariably achieved since this will help the Institute in meeting many of its capital needs; Efforts to increase the IGR has to be made;
