## NIEPMD, CHENNAI

#### Agenda 33.01

Confirmation of the minutes of the meeting of Previous Meeting (32nd EC).

#### **Decision:**

The Executive Council has confirmed the minutes of the previous EC meeting (32) held on 12/04/2018 at DEPwD, New Delhi.

#### Agenda 33.02

Action taken report on the resolutions of the 32<sup>nd</sup> meeting of the Executive Council held on 12/04/2018 at DEPwD, New Delhi.

#### **Decision:**

The Executive Council noted the Action Taken Report of the previous EC and advised the following:-

- i) 32.04:(ii) The estimates with all requisite documents are to be submitted to DEPwD at the earliest on the civil work of vertical expansion of the rear side of NIEPMD building.
- ii) 32.04:(iii) The total estimate for construction of skill training centre, adult training unit, P & O, ADIP Stores and research block is Rs. 36.40 crores. Post confirmation from AYUSH in writing for the amount of Rs. 10 crores, for the remaining Rs. 26.04 crores, detailed estimates with all requisite documents to be submitted to DPwED.
- iii) **32.**06: Department wise, course wise staff details are to be submitted separately for faculties, technical staff, projected staff and non technical staff. Status of Phase II recruitment is to submitted as part of ATR in the next EC.
- iv) 32.07: The EC asked for clarification on the total income and expenditure per annum from the hostel charges as per the new proposal. The details are to be submitted as part of ATR in the next EC.
- v) **32.10:** The EC observed that a journal will be published by selecting 10 good papers.
- vi) 32.19: On the issue of organizing the National Summit on Employment Opportunities for adults with Multiple Disabilities, NHFDC needs to be involved under intimation to Ministry. EC also advised to conduct job fairs regularly.



Approval of Annual Accounts for the Year 2017-18 of NIEPMD, Chennai.

#### Decision:

The EC approved the annual accounts of NIEPMD for the year 2017-18 and advised the following:-

- i) EC advised to stop utilisation of GIA in payment of interest on GPF with immediate effect.
- GPF corpus may be deposited in public sector banks providing better rates of interest.
- iii) GPF Corpus may be decided in the best interests of the Institute based on the study made with prior approval of EC, further the funds to be deposited in Nationalised Banks only.
- iv) NIEPMD will propose for ADIP funds which may include CRC-Kozhikode and CRC-Nagpur and after receiving funds; they may be transferred to the concerned CRCs.
- v) ADIP camps need to be organized in collaborations with NGOs / CSOs.
- vi) Proposals under AGP scheme of DEPwD to be immediately submitted to plan awareness creation of MD, ASD, CP, DB, SLD etc., included in the RPwD Act & DEPwD schemes etc.
- vii) EC noted NIEPMD depositing 40% advance to ALIMCO against procurement of ADIP materials and further noted the significant delay in delivery of ADIP materials to NIEPMD causing inconvenience in timely completion of targets & furnishing UCs. EC directed the Director to submit the detailed report to DEPwD immediately.
- viii) In SIPDA expenditure shown under the head "RAW MATERIAL" is actually "training cost" for skill development. Therefore, this expenditure in future is to be debited under the Head TRAINING COST.
- ix) CRCs are to be registered as CHILD AGENCY under NIEPMD in EAT module of PFMS.
- x) Separate Bank account for each CRC shall be opened through which funds for CRCs will be routed.

Development of models of employment opportunities for adult with multiple disabilities.

#### Decision:

The EC approved the proposal with total financial outlay of Rs. 30 lakhs @ Rs. 5 lakhs per programme.

#### **Agenda 33.05**

Research project- title: oral hygienic kit children with multiple disability.

#### **Decision:**

The EC approved the proposal in principle and advised to lay more focus on R&D activities and observed that all such R&D proposals are to be sent to DEPwD.

#### **Agenda 33.06**

Construction of SC/ST beneficiary building approval for vertical extension of additional floors on the SC/ST beneficiaries building at NIEPMD, Chennai.

#### **Decision:**

The EC approved the proposal. The EC further directed NIEPMD, to submit the proposal to construct 8 floors to DEPwD seeking funds from SC/ST funding from GOI. However, CSR funding may be explored for additional financial requirement.

# **DELEGATION OF ADMINISTRATIVE AND FINANCIAL POWERS TO DIRECTOR** Composite Regional Centres under the administrative control of NIEPMD, Chennai.

- a. To grant all kinds of leaves to Group A, B and C Staff except Director.
- b. To sign and issue of due increment certificates for all Group A,B and C Staff except Director.
- c. To engage any legal practitioner and to present the cases on behalf of the centre in consultation with Director, NIEPMD, Chennai.
- d. To insurance of assets of the centre for proper maintenance and upkeep after obtaining administrative and financial approval from Director, NIEPMD.
- e. All the Expenditures of the Composite Regional Centre should be incurred as per laid down procedure of GFR.
- f. Director, Composite Regional Centre is empowered to incur non-recurring expenses up to Rs.50, 000/- within the approved budget.
- g. All the TA/DA bills as per entitlements of the staff of Composite Regional Centre will be approved by Director, Composite Regional Centre.
- h. Director, Composite Regional Centre, can approve all Recurring Expenses as per approved Budget.
- Annual Receipt & Payment Account, Income & Expenditure Account, Balance sheet along with Schedules & Annexure will be prepared and submitted to NIEPMD, Chennai within one month of completing of the Financial Year.
- j. Director, Composite Regional Centre will submit, from time to time demand to Ministry for release of Grant by submitting Utilization of Grant, Expenditure Statement, proposed Expenditure and other information as desired by Ministry. This may be done after obtaining due approval from Director, NIEPMD.
- k. Director, Composite Regional Centre will propose Annual Action Plan and Budget before the Executive Council.
- The income received from services will be deposited in the Bank Account on daily basis by keeping proper account.
- m. All the Expenditures will be incurred after due approval of the competent authority; Composite Regional Centre will make all payments through Payment Vouchers and updating in Cash/Bank Accounts.
- n. The Centre should maintain proper register for Stocks, Assets as per laid down procedure of GFR.
- o. The Centre should maintain Receipt Voucher, Payment Vouchers and Journal Vouchers along with all supporting documents in separate files.
