1. SCOPE OF WORK

Terms & Conditions:

- a) Pharmacist with PwD will be preferred.
- b) One rooms with an outside counter with build-up area of Appx. 250 Sq. feet and accessibility features, connected with water and electricity facilities shall be provided by the Institute to run the Kendra.
- c) The Operator shall have to bear the Electricity Bill based on Institute HT line tariff charged by TNEB. A separate digital EB meter will be fixed for this purpose. The bidder should maintain the shop space properly.
- d) The Operator will arrange the furniture, fixture and Equipments required for the PMJAK.
- e) In case any Furniture /Fixture available with provided space the same will be maintained by the renter properly. The same will be handed over in the same condition at the time of end of contract.
- f) The Operator has to strictly keep the Kendra open during the working hours of the Institute. The Kendra will not be closed except on public holidays.
- g) It will be mandatory to keep only generic Medicines in the Kendra.
- h) The Operation of the Jana Aushadhi Kendra, NIEPMD will be done in the letter and script as per the Term & Conditions, guidelines for the operation of Jana Aushadhi Kendra.
 - i) Jana Aushadhi Kendra's complete accounts (Bill Deducting and Arrival, Sales etc.) and stock will be maintained through computerized system
- j) The Period of the Jana Aushadhi Kendra shall be for a period of Three (03) Years from the date of the contract operation and which shall be renewed every year as desired by the authority.
- k) The successful bidder shall deposit a sum Rs. 10,000/- (Rupees ten Thousand Only) through NEFT / RTGS in favour of The Director, NIEPMD as per account details provided in EOI. The payment receipt must be uploaded with technical bid as proof of EMD payment. Non uploading of receipt will leads to rejection of EOI.
- l) The Authority shall have right to reserve to Cancel the EO without assigning any reasons whatsoever. NIEPMD reserves the right to amend the terms & conditions of contract by mutual discussions and shall be in writing during the tenure of the contract. The amended terms and condition will form part of the agreement.

2. QUALIFICATION CUM TECHNICAL CRITERIA

The bids of only those firms will be considered who will satisfy the following eligibility criteria. The Pharmacist should possess the following documents before submission of the bid: -

- a) Valid Pharmacist Registration Certificate obtained from the Competent Authority in the State of Tamilnadu.

- b) Pass out Certificate of the Pharmacist.
- c) Income Tax PAN Number of the Pharmacist.
- d) Disability certificate in case of PwD.
- e) Declaration of non-engagement of regd. Certificate in any firm.
- f) Affidavit stating that there are so criminal antecedents pending against the Bidden Pharmacist in any court of law.
- g) The bidder obtaining minimum 50 marks or above will be considered for financial evaluation.

The Operators are required to subunit relevant documents duly attested by the authorized medical officer signatory in support of the eligibility criteria given above,

3. PAYMENT TERMS AND CONDITIONS

The price quoted by the firm, shall remain valid for the entire contract period. Payment shall be made at agreed rates except for Electricity, Water Charges, etc., which shall be charged as per actual consumption. No price variation shall be permitted during the tenure of the entire contract period. The agreed rent should be paid by the vendor to NIEPMD account as advance by the 25th date of previous month.

In case where the vendor wants to withdraw his contract, the information must be shared with the Institute at least 90 days advance in writing. Selected bidder cannot withdraw his offer during one year of contract period from date of award of contract. If so the performance security deposited will be forfeited and bidder will not be permitted to participated any institute tender for next 02 years.

(4) Tender Submission process

Interested bidder may submit their quotes by giving all the necessary documents in English or Hindi as specified. **The TENDER must be submitted online through Central Public Procurement Portal e-procurement application only through URL: <http://eprocure.gov.in/eprocure/app> only.** No manual bids will be entertained under any circumstances.

The Tender document attached must be direct, concise, and complete and arranged in an organized and structured manner.

To participate in online bidding process, Bidders must procure a Digital Signature Certificate as per Information Technology Act-2000 using which they can digitally sign and encrypt their electronic bids. Bidders can procure the same from any CCA approved certifying agency, i.e. TCS, Safecrypt, Ncode, eMudhra, sify etc. Bidders who already have a valid Digital Signature Certificate (DSC) need not procure a new DSC.

10. Force Majeure:

(a) For purpose of this Clause, "Force Majeure" means an event beyond the control of the Vendor and not involving the Vendor's fault or negligence and not foreseeable. Such events may include, but are not limited, acts of the Institute either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargo.

(b) If a Force Majeure situation arises, the Vendor shall promptly notify the Institute in writing of such conditions and the cause thereof. Unless otherwise directed by the Institute in writing, the Supplier shall continue to perform its obligations under the Purchase Order as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

11. Termination

The NIEPMD Chennai reserves the right to terminate the contract any day before availing the facilities without assigning any reason whatsoever. Without prejudice to the above the NIEPMD Chennai also reserves its right to terminate the agreement if the Bidder is involved in wrongful billing.
