Proposal for procurement of RO drinking water filter was initiated by AEMO. The proposal was referred to purchase committee by Director for re-tendering and to follow new government guidelines via publishing tender to CPPP portal. An open tender inquiry was initiated and M/s Bionics Advance Filtration, Delhi was declared L-1. The work order was placed to firm vide NIEPMD/Pur4 (32/2015-15 dated 29 Dec 14. After issuing the work order, the agency backs work order was placed to firm vide NIEPMD/Pur4 (32/2015-15 dated 29 Dec 14. After issuing the work order, the agency backs out and shows its inability to undertake the work on quoted rates hence the said work order was cancelled vide letter of even reference dated 07 Jan 15. As per latest CVC guidelines (No.98/ORD/1 dated 24th Aug 2000) Re-tendering approval was giving by the Director on 08 Jan 15. A short tender notice was initiated by publishing the NIT in one National Daily, one Tamil daily, Indian trade Journal, CPPP portal and institute website for wide publicity. Copy of NIT was forwarded to all previous bidders also via e-mail. The last date of opening of tender was 23 Jan 15. The committee met on 23 Jan 15 and opened the tenders received from following agencies: from following agencies:-

The committee opens the technical bids of above mentioned bidders. On evaluation and per-audit of bids by account officer it is noted by committee that M/S Kenz Technologies, Chennai does not have proper experience and work orders as required in our NIT also M/S Global Water Technologies does not have ISO certification which was a mandatory condition to qualify technically. Hence committee rejected the bids from m/s Kennz and m/s Global and price bids of these agencies not considered for opening. The committee noted that other three bidders are fulfilling the technical requirement as document attached with their technical bids. The committee requested to technical qualified bidders to produce sample of RO machine with full accessories to verify the details quoted in their bids. The all three agencies displayed their samples in front to committee on 18 Feb 14. On evaluation samples with document it is found that all three bidders fulfilling the technical criteria hence there financial bids considered for opening. Committee opened the technical bids of M/S Ozone Technologies, M/S Unique Aqua Systems & M/S Aqua Yaga Systems and CSQ is appended below for quick comparison:-
